# WAIVER/CONSENT FIGURE SKATING POLICIES

*Please read and sign*

- The Novi Ice Arena and Suburban Sports Group (herein after referred to as Novi Ice Arena) shall not be liable for any and all claims or actions of any kind whatsoever for injuries, damages or losses of any kind to persons or property which may be sustained in connection with any Novi Ice Arena activity.
- Recognizing the normal risk of skating on ice, I agree to skate at my own risk and to abide by all skating policies established by the Novi Ice Arena, the Novi Ice Arena management and/or professionals. The Novi Ice Arena assumes no responsibility for accidents on or off the ice, or damage to personal property.
- In the event an emergency situation arises, in which I/we are unable to be contacted or any unavailable for immediate authorization, I/we give permission to \_\_\_\_\_, or if unavailable, to the Novi Ice Arena, to arrange for emergency procedures for the contracted skater at a local hospital, or by a physician, and agree to hold all parties harmless.
- The Novi Ice Arena reserves the right to cancel scheduled events without liability, other than reimbursement credit.

- Participant acknowledges that during the course of participation in Novi Ice Arena activities, the Novi Ice Arena may take photographs, audio recordings and/or video recordings of participant. Participant hereby grants the Novi Ice Arena permission to use any and all such photographs or audio or video recordings of the participant for advertising, promotional or educational purposes. Such use may include publication in programs, advertising, posters, flyers, radio, television or other methods, and may be seen or heard by large numbers of individuals, including potential customers of the Novi Ice Arena. Participant waives all rights to any financial remuneration of any such use.

## **Injury Policy**

If a skater is unable to skate for 30 or more days due to any injury or illness; they may request that their contract be canceled until the skater can resume full skating activities. This request should be in writing with a doctor's letter indicating the extent of the injury, to document the request. The contracted skater is responsible for paying their full Novi Ice Arena membership and all ice contracted until the Novi Ice Arena is notified.

## **Novi Ice Arena Skaters Policies**

1. Skaters must sign in with the monitor before taking the ice for the day.
2. Changes are a switch or trade of a day or session, not a deletion. A deletion is a removal/void of a day or session and that is nonrefundable.
3. Absolutely no eating, drinking or gum chewing on the ice with the exception of water bottles.
4. Proper respect must be shown to all Professionals, monitors, off ice instructors and parents.
5. Do not interrupt Professionals while they are in a lesson.
6. SKATERS IN A PROGRAM OR LESSON HAVE THE RIGHT OF WAY. Skaters must wear an orange vest while skating their programs!
7. No foul language or show of temper is allowed.
8. Kicking holes in the ice is inexcusable and you will be asked to leave the ice.
9. All skaters are asked to leave the ice **immediately** when the ice resurfacers driver sounds the buzzer.
10. No radios or cassette players will be allowed on the ice, excluding Professionals.
11. Dressing rooms and other areas around the arenas are to be left clean and all debris picked up and put in trash containers.
12. NO EQUIPMENT OR CHANGING IN THE CONCESSION AREA. USE THE DRESSING ROOMS.
13. Ice is for skating, not visiting. If you must visit, please leave the ice.
14. All parents are welcome to view skaters from the arena stands or upper lobby viewing area. No parent is allowed to be at the door on the ice level or in the bench music area without approval from arena management. If a coach or skater is interrupted by a parent during a session, the parent could be asked to leave the building. This includes videotaping skaters from ice level.

Skaters who cannot abide by the above rules may be asked to leave the ice. Their names will be recorded and parents will be called if necessary. Repeated or serious infractions of the rules will be referred to the discipline committee and loss of ice privileges may ensue.
