1. Skaters must be **current USFS Members** and must provide USFS Number with contract.

2. Skaters must **sign in** with the monitor or front office <u>before</u> stepping on the ice.

3. Skaters must use the SCN Locker Room (SCN Members only) or the downstairs lobby to change skates and equipment.

4. All participants are expected to be respectful towards all professionals, instructors, staff, fellow skaters, and parents.

5. There is a zero tolerance policy for offensive and abusive behavior and language.

6. All skaters must read the Freestyle Rule Document and hand in a signed Acknowledgement page to the Front Desk.

7. Repeated or serious infractions of the rules will result in loss of ice privilages. All skaters and parents must adhere to the skater and parent code of conduct set forth by USFS.

8. Skaters and parents must understand that participants skate at their own risk and that they are expected to abide by all skating policies estabilished by the Novi Ice Arena management and/or professionals.

9. The Novi Ice Arena shall not be liable for any and all claims or actions for injuries, damages, or losses of any kind to persons or property which may be sustained in connection with any Novi Ice Arena activity.

10. The Novi Ice Arena assumes no responsibility for accidents on or off the ice, nor to damage to personal property. 11. If a skaters is unable to skate for 30 or more days due to an injury or illness, they may request that the contract be canceled from the date of injury or illness until they are able to resume full skating activities. Request must be in writing and include a doctor's note.

12. Contracted skaters are permitted three (3) make-up sessions per session contracted within one contract period. (make-up sessions are non-transferable)

13. Contract adjustments are offered at the discression of the Skating Director. Two week prior notice must be send to the Skating Director for consideration.

14. 72 hour prior notice for make-up sessions must be sent via email to the Skating Director for consideration.

15. No make-up sessions are permitted if notice is given after the original session has occurred.

17. Contracted spots may not be shared with other skaters.

18. The Novi Ice Arena reserves the right to cancel scheduled events without liability, other than reimbursement credit. 19. Freestyle sessions are for training purposes only. Skaters will be asked to leave the ice if they are using it for other purposes.

20. Skaters in a lesson and those skating to music have the right of way.

21. If you do not meet contract minimum, you will be charged full rate of \$8.50/25-minute session.
